In foreign Countries, many acts are passed before Notaries
 as Contracts of Marriage, deeds of Gift, Contracts of Sale,
 Leases, Compositions, &c. And the Notaries grant only Fac-
 tifications or Duplicates to the parties or other persons
 who ought to have them, who have a right to Demand
 them. In which case Exemplifications or Duplicates
 subscribed by the Notaries, is to keep the originals or papers
 the Acts which contain some obligation of one party toward
 another, being signed by a Notary public, give a right of
 Mortgage on the Estate of the person who is bound. See

 their presence. These Instruments of Notaries are the only

 of Law, as the Giving of Testimony, making a Recognition, pro-
 mation, Requisition, Confession, &c. But are not sufficient
 in any thing except what falls under the sense of bearing

Notaries being Required, are obliged to give Instru-
 ments upon whatsoever is said or done, at the Protesting or
 taking Instruments in their hands, whether it be any part
 of the requisite solemnity or No. But such things as are
 part of the necessary solemnity of the Act, must be subscribed
 by
