The Trial may be prob'd by either each the Receiver of the Right 994.

Rights acquired by a dodder's alias from a stranger in name of a
conjunct person, are affectable by way of Declaration, at the instance of the
creditors of such Dodger 995.

A Bankrupt cannot in the prejudiciale
of the more timely diligence commenced by one creditor to affect his
estate or prior the right, greatly another by belated payment or Right to
the Estate 996.997.998. nor can he impeach a Dodger to do so 999.1000.

His collection with one creditor, to give him the share of diligence before another,
is also restrained 1000. The creditor cannot safely acquire none of the Re-
sizable Rights granted by a partner in trust to one of his creditors to the prejudice
of another current diligence 998.999.

As they may acquire Rights to
Mortables 999. Reduction upon the Act of parliament 1621 against Bankrupts
is not excluded by a separate Right in this person of the Dodger 994.

But it is relevant to prove either that his author had a sufficient Estate
already, or to affect to pay the purifier 906.907. A creditor has action to
recover in whole or in part the amount paid by his Bankrupt to another creditor
in the prejudiciale of the former diligence 1000.1001. what he is due in
the Event of Rediction of a Right to the prejudice of creditors 1001.
